I. These guidelines are formulated to handle the academic affairs and enrollment of students going abroad during their term of studies.

- 二、 本要點適用之學生如下:
- II. These guidelines shall apply to the following students:
 - (一) 經本校甄選為交換生或自費選讀生前往有合作關係之國外學校或機構者。
 - (1) students selected by the University or self-funded for exchange programs at overseas partner universities or institutions,
 - (二) 從事短期交流、實習、研修或學位論文相關研究者。
 - (2) students carrying out short-term exchange, internships, studies, or thesis/dissertation-related research,
 - (三) 經所屬院、系所、學位學程推薦並經學校核准出國就讀雙學位者。
 - (3) students recommended by their affiliated departments/institutes/degree programs/colleges (hereinafter referred to the "units") and approved by the University to study dual-degree programs,
 - (四) 修習之課程須短期出國研修者。
 - (4) students taking courses which require a short-term research overseas,
 - (五) 其他經本校專案核准出國者。

Any dispute over interpretations of these regulations shall be resolved in the court of law based on the Chinese version.

- (5) students specially approved for going overseas by the University.
- 三、 出國經專案核准者是否須辦理休學,由各院、系所、學位學程決定。 休學應依本校學則相關規定辦理。
- III. Individual units may determine whether students approved to study abroad shall apply for suspension of their studies. Matters related to the suspension shall be handled in accordance with the University's *Academic Regulations*.
- 四、 學生出國期間相關事項如下:
- IV. Students shall handle the following matters while studying abroad:
 - (一) 出國期間仍應辦理本校註冊手續(或委託他人代為辦理)。
 - (1) Students shall complete their enrollment or delegate a third party to do so while studying abroad.
 - (二)因交換學校為國際緊急情勢地區者(如疫情、政局、天災等),得申 請提前返校;返校後學籍及選課事宜由教務處協助辦理;返校相關 事宜及於國外修課相關資料由國際事務處協助辦理。
 - (2) If students apply for returning back to the University early due to partner universities facing emergencies such as epidemic outbreaks, political unrest, or natural disasters, the Office of Academic Affair shall handle the enrollment and course selection upon their return, and the Office of International Affairs shall assist with their repatriation and academic records in partner universities.
- 五、 學生依本要點第二條規定出國而未辦理休學者,於國外大學所修習之 科目學分及返校手續依下列規定辦理:
- V. Students studying abroad without suspending their studies per Article 2 herein shall handle their course credits and returning procedure as follows:
 - (一) 境外修習之科目學分,得依本校「辦理學生抵免學分辨法」申請抵免,惟學生所屬系所無名稱、內容或性質相同之課程可辦理抵免者,得依「本校學生成績作業要點」申請認列學分。 學生如欲抵免或認列本校學分,應事先辦理完成出國申請之相關程序。
 - (1) Course credits obtained at overseas partner universities/institutions may be transferred in accordance with the University's *Regulations for Credits Transfer*. However, for courses taken overseas without one with the same title, content, or nature in the students' affiliated departments, the students may apply for credit recognition according to the University's *Guidelines on Academic Evaluation*. Students who plan to apply for credit transfer or recognition shall complete the required procedure for studying abroad.

- (二) 返國後二個月內檢附國外交換學校或機構修習科目之成績單正本(或成績證明書)及相關授課證明(應含授課時數及註明修習之科目為大學部或研究所)併同返校手續單辦理返校手續;
- (2) Within two months upon return, students shall submit the original transcript (or a certificate of academic record) issued by the overseas universities/institutions, proofs of courses taken (indicating the number of lecturing hours and the courses being offered in a bachelor's or master's program), and the returning procedure check list for matters related to students' return.

應屆畢業生至遲需於次學期上課開始日前完成審核作業,逾期次學期仍應辦理註冊。

Graduate-to-be shall complete the returning procedure before the first date of the class in the upcoming semester. Those failing to do so shall still enroll for the next semester.

- (三) 學生出國進修時間得列入修業年限計算,至多以一年為原則。
- (3) The period of studying abroad shall be counted toward the number of years for study up to one year, in principle.
- (四)因第四點第二款提前返校者,於完成返校手續後,得經所屬單 位及授課教師同意,協助其加修校內可銜接之相關課程,不 受當學期選課期程之限制,其成績計算方式依本校成績評量 相關規定辦理。
- (4) Students returning from overseas early per Subparagraph 2 of Article 4 herein may select corresponding courses with the consent of their affiliated units and teaching faculty after completing returning procedure. They are thus not subject to the schedule of course selection, and the grading method shall be handled in accordance with the University's relevant regulations for evaluation.
- (五) 境外修習科目學分之計算,得依本校交換校學分轉換參考表 (如附表 1)辦理。倘有需個別認定之情形,得由學生檢附 修習學分、修課時數及成績相關證明文件等,由系所依本校 學則第四十七條規定予以認定(原則以授課滿十八小時為一學 分)。學分轉換若遇有小數部分,得經系所認定後以四捨五入 方式採計學分。
- (5) The calculation of course credits obtained abroad shall follow the University's *Tables for Converting Credits of Exchange Programs* (Appendix I). The credit number of a course of special nature may be recognized on a case-by-case basis with corroborating

documentation regarding course credits, class hours, and grades by the students' affiliated units in accordance with Article 47 of the University's *Academic Regulations* (eighteen teaching hours is equivalent to one credit, in principle). Converted credits with decimal points shall be rounded to the nearest whole number.

- (六) 境外修習科目之成績及格標準認定,得依本校交換校成績轉換 參考表(如附表 2)辦理。倘有需個別認定之情形,應符合 本校學則規定之各學制成績及格標準,經系所同意後採計學 分。
- (6) The passing grade of courses taken abroad shall follow the University's *Tables for Converting Grades of Exchange Programs* (Appendix II). A course of special nature may be reviewed on a case-by-case basis by the students' affiliated units. The credits shall be recognized upon approval for passing in accordance with the provisions regarding passing grades for various programs stipulated in the *Academic Regulations*.
- 六、 學生出國期間,如有違反校規或其他不端情事或逾期未返校者,依學 則及相關規定辦理。
- VI. Matters related to students violating the University's regulations, misbehaving, or deferring the return date while studying abroad shall be handled in accordance with the *Academic Regulations* and other relevant regulations.
- 七、
 學生出國期間有關兵役事宜,除依其相關規定辦理外;役男尚未履行
 兵役義務者,另依內政部頒「役男出境處理辦法」辦理。
- VII. Matters related to military service shall be handled in accordance with relevant regulations. Drafted students not yet serving the military duty shall comply with the Ministry of the Interior's *Regulations for Exit of Draftees*.
- 八、 學生出國,有關申請護照及入出境許可,支領,停發或賠償公費及獎學金,或其他未規定事項,另依相關規定辦理。
- VIII. Matters not covered herein shall be handled in accordance with other relevant regulations, such as passport application, entry/exit permit, and withdrawal/suspension/compensation of the state-funded subsidies and scholarship.
- 九、 本要點經教務會議通過,經校長核定後公告實施,修正時亦同。
- IX. These guidelines are approved by the Academic Affairs Council and announced for the implementation after approved by the President. Amendments to these guidelines shall follow the same procedure.
