Rules for Distinguished Alumni Award Nomination of the College of Engineering of National Sun Yat-sen University

- 1. The Rules for Distinguished Alumni Award Nomination (hereinafter referred to as "the Rules") of the College of Engineering (hereinafter referred to as "the College") are formulated in accordance with the Regulations Governing the Selection of Distinguished Alumni of National Sun Yat-sen University (hereinafter referred to as "NSYSU").
- 2. Nomination Purpose: Recognize distinguished alumni of NSYSU to enhance NSYSU's reputation and encourage current students.
- 3. Eligibility: Alumni who are not current students of NSYSU.
- 4. Nomination Criteria: Alumni with any achievement which falls into one of the following categories can be nominated:
 - (1) **Academic Excellence:** Professionally demonstrate outstanding performance in the chosen field of academic research.
 - (2) **Business Elite:** Enjoy a high level of success in starting a business or business operation and value corporate social responsibility.
 - (3) **Social Service:** Make significant contribution to social welfare, national infrastructure, the development of NSYSU, or the development of any alumni association at the university/college/department/institute level of NSYSU.
 - (4) **Culture and Art:** Create distinctive artworks or demonstrate outstanding performance in culture or art.

5. Nomination Method:

- (1) Nominated by any alumni association of a department/institute under the College.
- (2) Nominated by any department/institute under the College.
- (3) Self nomination to any department/institute or its alumni association.

6. Procedure:

- (1) Each department/institute notifies alumni and their alumni association by the end of every January to openly recruit candidates for the Distinguished Alumni Award and initiate the nomination procedure.
- (2) Each department/institute submits the required information on candidates to the College by the end of every April.
- (3) The College calls the executive meeting to select up to 2 candidates for each category and submits its nominations of distinguished alumni to the Distinguished Alumni Selection Committee of NSYSU by the end of May.
- (4) Candidates nominated by the College will receive the Distinguished Alumni Award of the College.
- 7. The Rules become effective after being approved at the College Affairs Meeting. Amendments to the Rules shall follow the same procedure.
