

# **National Sun Yat-Sen University**

## **Guidelines for Selection of Advisors**

Modified and approved at the 100<sup>th</sup> meeting of academic affairs, June, 11, 2004

- Article 1 The Guidelines are established to provide a basis for the department (institute) to select advisors.
- Article 2 The advisor shall be an assistant professor or a professor of a higher level, and be qualified to act as an examination committee member according to the Degree Conferral Law.
- Article 3 The advisor shall be a full-time teacher of the department, but a part-time teacher or a teacher from another department (institute) can be selected as an advisor in consideration of the professionalism or shortage of teachers.  
A teacher or expert outside the university can be invited to act as an advisor if no teacher from the university can be arranged to do the job, but a teacher from the university must be arranged to act as a co-advisor.
- Article 4 The advisor can continue giving instructions after retirement or leaving the university, but a teacher from the university must be arranged to act as a co-advisor.
- Article 5 The department (institute) that has been established for no more than three years may invite a teacher from outside the university to act as an advisor due to a shortage of teachers. Article 3, Section 2 is not applicable in this case.
- Article 6 Selection of an advisor is subject to the Guidelines unless the department (institute) establishes other regulations stricter than the Guideline.
- Article 7 The Guidelines are implemented after being approved at the meeting of academic affairs. The same procedure is applicable to the amendment of the Guidelines.

(These guidelines are enacted in Chinese, which shall prevail in case of any discrepancy between the English translation and the Chinese original.)

# 國立中山大學論文指導教授遴聘原則

九十三年六月十一日第一〇〇次教務會議修正通過

- 一、為使本校各系(所)遴聘論文指導教授有所依循，特訂定本原則。
- 二、論文指導教授須為助理教授以上，並符合學位授予法學位考試委員之資格。
- 三、論文指導教授應以本系專任教師指導為原則，若因專業領域或系所師資不足，得商請本校其他系所教師或兼任教師擔任。  
指導教授若無法商請本校教師擔任，得商請校外教師或專家學者擔任，惟須另安排本校教師一人共同指導。
- 四、論文指導教授若退休或離職，仍可繼續指導，惟須另安排本校教師一人共同指導。
- 五、三年內新成立之系所，因師資不足，指導教授得商請校外教師擔任，不受本原則第三條第二項之限制。
- 六、論文指導教授除系所另有更嚴格之規定從其規定外，悉依本原則辦理。
- 七、本原則經教務會議通過後施行，修正時亦同。
