- For the full-time teahers in this department, the percentages of the evaluation items are: 40% for performances or research, 40% for teaching, 20% for service and counseling. Teachers who have a "Major Illness Card" or " Disability Identification", the percentage can be adjusted within the following range: 30%-50% for performance or research, 40%-60% for teaching, 10%-30% for service and counseling.

- 4. Performance or research (within five years): a total score of 100 points.(According to the National Sun Yat-sen University Teacher Evaluation Indicator)
- 5. Teaching part (within five years): a total score of 100 points. (According to the National Sun Yat-sen University Teacher Evaluation Indicator)
- 6. Service part (within five years): The total score is 100 points. (According to the National Sun Yat-sen University Teacher Evaluation Indicator)
