National Sun Yat-sen University Regulations Governing Subsidy for Academic Activities

Approved at 1st University Council MTG of AY 2003, October 31, 2003 Amended and Approved at 9th Admin MTG during the 2nd SEM of AY 2013, June 18, 2014 Amended and Approved at 1st Admin MTG during the 2nd SEM of AY 2015, Mar. 9, 2016 Amended and Approved at 1st Admin MTG during the 2nd SEM of AY 2016, Feb. 22, 2017 Amended and Approved at 5th Admin MTG during the 1st SEM of AY 2019, Oct. 30, 2019

- Article 1 The Regulations are established to encourage teachers and students of the University to proactively participate in international academic activities, to promote academic exchanges, and to enhance the academic standards of the University.
- Article 2 Source of funding for subsidization of academic activities of the University: University Endowment Fund.
- Article 3 Items and subject of subsidization:
 - 1. Paper publication subsidy: The publication cost required for publication of an academic paper by full-time staff, full-time students and retired teachers of the University, that specifies the name of the University, in an important international academic journal, which has not been fully subsidized by any other units, or where there is no appropriate reason for applying for subsidization by any other units.
 - 2. Traveling allowance for chairing or participating in an important international academic conference: Where full-time staff and full-time students of the University is invited by an international academic conference to serve as the chairperson or publish an academic paper, and no authors of such paper has been fully subsidized by any other units, or there is no appropriate reason for applying for subsidization by any other units; the definition of an international academic conference is governed by the definition adopted by the Ministry of Science and Technology.
 - 3. Subsidy for hosting an academic conference (an "academic conference" generally refers to a Workshop, Symposium, Conference or Seminar):

 Academic conferences may be of 3 types:
 - Type 1: Hosting or commissioning the holding of an international and academically-related conference or symposium.
 - Type 2: Hosting or commissioning the holding of an academic discipline-related annual academic conference recognized by the Ministry of Science and Technology.
 - Type 3: Hosting or commissioning the holding of an important academic symposium that has been assessed and approved.
 - 4. Subsidization of academic exchanges: In order to reinforce and

- encourage academic exchanges between the University and other academic organizations within and outside Taiwan, each department may enter into collaboration and exchange agreements with other schools, and carry out various exchange activities.
- 5. Holding academic result presentations: Presentation of individual special academic results of teachers of the University (such as concerts or musical performances) or group artistic performances.
- 6. Holding academic competitions: Academic competitions at the national level or above hosted by the University.
- Article 4 The Academic Activity Subsidy Assessment Committee (hereinafter "Assessment Committee") is formed to assess subsidization of academic activities of the University.

The Committee will comprise of members convened by the Senior Vice President.

- Article 5 The assessment rules will be as established by the Assessment Committee.
- Article 6 The responsible unit is the Office of R&D, to be responsible for the routine procedures.
- Article 7 The Regulations shall be enforced upon approval of the administrative meeting. The same shall apply where the Regulations are amended.
