Guidelines on Rewarding Doctoral Students with

Commendable Research Performance

112年4月26日111學年度第2學期第6次行政會議修正通過

Amended and approved at the 6th Executive Meeting on April 26, 2023

- 一、為有效提升本校研究風氣並鼓勵優秀博士生,訂定本要點。
- I. These guidelines are formulated to effectively foster the research culture at the University and encourage outstanding doctoral students.
- 二、經費來源:本校「學生公費暨獎助學金」。
- II. Funding of the awards is sourced from the "Government Fund for Student Scholarships".
- 三、獎勵對象條件及名額
 - III. Award Recipients and Quotas
 - (一)本獎勵金發放對象為就讀本校博士班期間,以本校名稱且為第一單位 發表論文獲刊登於SCIE、SSCI、AHCI、TSSCI、THCI 等期刊之博士 生,得於入學後第二至第四學年度提出申請。獲獎以一次為限。
 - (1) Award recipients shall be doctoral students who has published papers in SCIE, SSCI, AHCI, TSSCI, and THCI journals during their studies with the University as the first affiliated unit. They shall submit an application during their second to forth years and the award shall be granted only once.
 - (二)前款獎勵對象不含大陸地區學生。
 - (2) The award recipients stipulated in the preceding subparagraph shall exclude students from China.

- (三)獎勵名額約20名,依各學院博士生入學第三年在學人比例核定(四捨五入),各學院至少1名。
- (3) The award quota shall be 20, in principle. Individual colleges shall be given the quota proportionally (rounded up) based on the number of doctoral students studying in their third year, with at least one award recipient in each college.

四、申請及推薦

IV. Application and Recommendation

- (一)符合獎勵對象條件者,應於每年5月1日至15日向所屬學院提出申請, 並由各學院審查後,於5月30日前將推薦名單送達本校研發處彙整。
- (1) Applicants meeting the criteria shall submit an application to their affiliated college from May 1 to 15 each year. After reviewed by the college, a list of recommended candidates shall be submitted to the Office of Research & Development Office by May 30 for compilation.

(二)各學院推薦名單的排序如下:

- (2) The order of recommended candidates of each college shall be listed as follows:
 - 第一作者或通訊作者且曾申請國家科學及技術委員會博士生赴國外研究(千里馬計畫、臺德三明治等)補助者。
 - i. The student is the first or corresponding author and has applied for the NSTC's Graduate Students Studying Abroad Program or NSTC-DAAD.
 - 2、第一作者或通訊作者。
 - ii. The student is the first or corresponding author.
 - 3、共同第一作者或共同通訊作者(equal contribution),惟同一篇論文

僅能申請1次且限1人申請。

iii. The student is the co-first author or co-corresponding author (equal contribution) with the paper used only for one of the authors and only once.

五、審查標準及獎勵金額度:

V. Review Criteria and Award Amount:

(一)審查標準

- (1) review criteria
 - 1、獲刊登於SCIE、SSCI或AHCI期刊之論文,以Journal Citation Reports (JCR)排名百分比為主,如該論文發表期刊無JCR排名百分比,方得參酌Journal Citation Indicator (JCI) 排名百分比評定之。
 - i. Papers published in SCIE, SSCI, or AHCI journals shall be primarily evaluated based on the ranking percentile by Journal Citation Reports (JCR), otherwise by Journal Citation Indicator (JCI).
 - 2、獲刊登於THCI或TSSCI第一級期刊之論文,以C類論文且排名百分比 50%計。
 - ii. Papers published in top-tier journals of THCI or TSSCI shall be considered as Category C papers and evaluated at 50% of the ranking percentile.
 - 3、提出申請之論文篇數超過1篇時,至多採計3篇論文排名百分比之平均,作為審查論文表現依據。
 - iii. If an applicant submits more than one paper for review, the average ranking percentile of the top three papers shall be used as the basis for evaluation.

- 4、獎勵論文以原創論文(original article)為主,惟A類論文至多得採計1 篇綜論型論文(review article)。
- iv. Original articles shall be the main type of papers eligible for the award. For Category A papers, only one review article shall be considered.

(二)獎勵金額度:

- (2) award amount
 - 1、A類論文:論文JCR資料庫分類領域之Journal Impact Factor(JIF)或 JCI排名為該學門領域前(含)10%,每名學生獎勵10個基數。
 - i. Category A papers: If an applicant's paper is published in a journal ranked in the top 10% of a specific field in the JCR database based on either Journal Impact Factor (JIF) or JCI, 10 units shall be granted.
 - 2、B類論文:論文依JCR資料庫分類領域之JIF或JCI排名為該學門領域11%至25%,每名學生獎勵7個基數。
 - ii. Category B papers: If an applicant's paper is published in a journal ranked in the top 11% to 25% of a specific field in the JCR database based on either JIF or JCI, 7 units shall be granted.
 - 3、C類論文:論文依JCR資料庫分類領域之JIF或JCI排名為該學門領域 26%至50%,每名學生獎勵4個基數。
 - iii. Category C papers: If an applicant's paper is published in a journal ranked in the top 26% to 50% of a specific field in the JCR database in based on either JIF or JCI, 4 units shall be granted.
- (三)前款百分比計算均採四捨五入計算,每1基數所代表的金額比照本校當 年度彈性薪資基數之金額。

(3) The number of percentile stipulated in the preceding Paragraph shall be rounded up. One unit shall be equal to one merit pay unit of the University for the current year.

六、獎勵名單核定原則

VI. Principles for the Approval of Award Recipients

- (一)當年度核定獎勵名單,以各學院依分配名額所推薦名單為原則。如有疑義 ,則召開決審會議審議,由副校長擔任召集人,研發長及各學院院長為當 然委員。
- (1) Award recipients for the current year shall be determined based on the recommended list by individual colleges, according to their allocated quota. In case of doubt, a senior vice president shall convene an ad hoc meeting with the Vice President for Research & Development and individual college deans as the ex-officio members.
- (二)理工海醫學院博士生已發表3篇JCR排名為該學門領域前10%之論文時,或 文管社學院博士生已發表1篇JCR排名為該學門領域前10%之論文時,惟該 學院得獎分配名額不足,得提報決審會議審議。
- (2) When there are applicants from the colleges of Science, Engineering, Marine Sciences or Medicine who have published three (3) papers, or from the colleges of Liberal Arts, Management or Social Science who have published one (1) paper in the journals ranked in the top 10% of their respective field, based on the JCR database, who are beyond individual college's quota, the case shall be submitted to the ad hoc meeting for deliberation.

七、獎勵金保留及放棄機制

- VII. Mechanism for Award Retention and Relinquishment
 - (一)獎勵金之受獎者休學,應填寫「博士生研究績優獎勵金保留領取聲明

- 書,並按月份比例退回已領取之獎勵金,保留受獎資格於保留期滿後 未復學者,視為放棄獎勵金領取資格。
- (1) Recipients who suspend their studies shall submit the "Declaration for Retention of the Award for Doctoral Students' Commendable Research Performance", and return the received award in proportion to the number of months during which studies are suspended. Recipients who fail to resume their studies after the retention period expires shall be deemed to relinquish their award.
- (二)獎勵金受獎者受退學處分,取消其受獎資格並按月份比例追繳已領取 之獎勵金。
- (2) Recipients dismissed from the University shall be disqualified from receiving the award, and return the award amount.

八、本要點經行政會議通過,陳請校長核定後實施,修正時亦同。

VIII. These guidelines are approved by the Executive Meeting and the President before implementation. Amendment to these guidelines shall follow the same procedure.
